What is this product?

Type

The fund is a contractual umbrella fund under Swiss law of the type "Securities funds" pursuant to the Swiss Federal Act on Collective Investment Schemes (CISA) of June 23, 2006 with several subfunds.

Objective

This actively managed subfund aims to achieve long-term capital growth.

The subfund mainly invests directly or indirectly in equities and equity-like securities of companies which are domiciled in or which carry out the bulk of their business activities in the USA and which take the sustainability criteria into account.

Derivatives can be used for hedging purposes and for efficient portfolio management. This does not produce a leverage effect.

Shares in the subfund can be redeemed on any working day, with the exception of public holidays in Switzerland or when a significant part of the stock exchanges and markets of the subfund is closed.

Income is not paid out but is retained to be reinvested.

V shares are reserved for investors who have a banking relationship with a company of the Vontobel Group at the time of subscribing or who invest through a financial intermediary which has signed a cooperation agreement or similar agreement with a company of the Vontobel Group. The shares do not grant any discounts or retrocessions.

Taking into consideration the minimum recommended holding period, the return will depend on the performance of the underlying investments. The custodian bank of the fund is State Street Bank International GmbH, Munich, Zurich Branch.

This subfund is part of an umbrella fund. The different subfunds shall not be held liable for one another, i.e. investors in this subfund need only be concerned with their own profits and losses. In accordance with the "Further information" chapter in the sales prospectus, each investor may request to convert all or part of their shares into shares of another subfund in the same share class.

Intended Retail Investor

The sub-fund is intended for retail investors with knowledge and/or experience of these types of products, that have medium to long-term investment horizon and that have the ability to bear losses up to the amount they have invested in the sub-fund.

Term

This product has no expiration date. The subfund was established for an indefinite period of time. The fund management company is unilaterally entitled to liquidate the product at any time. The amount received by the investor in the event of early termination may be less than the amount invested.

What are the risks and what could I get in return?

The summary risk indicator (the "SRI") is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

This rates the potential losses from future performance at a medium-high level, and poor market conditions will likely impact our capacity to pay you.

Be aware of currency risk. In some circumstances, you may receive payments in a different currency, so the final return you will get may depend on the exchange rate between the two currencies. This risk is not considered in the SRI.

Other risks not captured in the SRI: liquidity, operational, legal or sustainability risks. Further details in the prospectus.

What happens if Vontobel Fonds Services AG is unable to pay out?

The investor may not face a financial loss due to the default of the Product Manufacturer.

The assets of the Fund are held in safekeeping by its Custodian Bank, State Street Bank International GmbH, Munich, Zurich Branch (the "Custodian"). In the event of the insolvency of the Product Manufacturer, the Fund's assets in the safekeeping of the Custodian will not be affected. However, in the event of the Custodian's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. This risk is mitigated to a certain extent by the fact that the Custodian is required by law and regulation to segregate its own assets from the assets of the Fund. The Custodian will also be liable to the Fund for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfill its obligations (subject to certain limitations as set out in the agreement with the Custodian).

Losses are not covered by an investor compensation or guaranteed scheme.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Cost over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

How long should I hold it and can I take money out early?

Recommended holding period: 5 years

Due to the investment policy and the risk profile of the subfund, a holding period of 5 years is recommended. Investors can sell the investment at any time at no additional cost regardless of the recommended holding period. Units may be sold on a daily basis (on bank working days). The exit costs are shown above.
