Annex to the semi-annual report of the Investment Company (Art. 1055 / Art. 1091 PGR)

Credit Suisse Funds SICAV (FL-002.269.548-0) is a third-party managed Investment Company having the legal form of a stock corporation with variable capital (SICAV) under Liechtenstein law of the type undertaking for collective investment in transferable securities (UCITS).

The present semi-annual financial statements (pages 6-9) cover the financial period of the Investment Company from 01 June 2024 to 30 November 2024.

Accounting principles

The presentation and structure of the annual financial statements correspond to the statutory regulations of the Liechtenstein Persons and Companies Act (Personen- und Gesellschaftsrecht – "PGR"). Liquid assets, receivables and liabilities are reported at nominal value, taking account of any possible necessary provisions. Prepaid expenses and prepaid income represent expenses or income recorded before the balance sheet reporting date that will lead to expenditure or revenues only in following reporting periods.

Currency

Foreign currency translation

Receivables and liabilities of the Investment Company in foreign currencies are valuated as at the reporting date at the following exchange rates:

Financial assets

The subfunds managed by the Investment Company and their net fund assets are reported under financial assets. Valuation is at fair value (net fund assets of the subfunds are as of the reporting date). Simultaneously, the net fund assets of the subfunds are included in the liabilities of the Investment Company. The subfund assets are segregated in favor of the holders of the investor units and is not included in the Investment Company's bankruptcy estate in the event of bankruptcy.

Income statement of the Investment Company

The income statement of the Investment Company discloses the revenues and expenditure that are attributable to the share capital.



Investor units

The Investment Company has issued registered founder shares with par value and bearer investor units without par value on the basis of its Articles of Association. Investors participate in the assets and revenues of the individual sub-funds in proportion with the number of units they have acquired. Investor units do not, however, confer voting or other membership rights. They also do not confer the right to participate in the profits of the Investment Company.

In the 3rd quarter of 2024, economic data disappointed in almost all regions. Concerns about growth came to the fore. With inflation continuing to decline, it is not only the market's hopes of interest rate cuts that have risen significantly, leading to falling bond yields. Almost all major central banks have now cut interest rates. In Europe, the outlook remains lacklustre. Leading indicators point to an economic slowdown and the political situation in France, but also in Germany, is unstable. In October, the ECB lowered the key interest rate by -25 bps to 3.25% for the third time this year. The ECB also indicated that a further decline in key interest rates was likely. Maturing bonds are only partially reinvested as part of their purchase programmes, so that the portfolio shrinks by 30-35 billion euros per month.

Due to the inverted yield curve, we tend to keep duration short and invest primarily in the maturity range of up to 6 months. In terms of investments, we focus on diversification and liquidity. The fund volume fell sharply in the summer, then rose briefly in the 3rd quarter and decreased again towards the end of the reporting period. Due to the smaller fund size, we are investing mainly in bonds with remaining time to maturity of around one year or below. The liquidity and supply allow for a broad diversification of issuers. Investments in commercial paper have become somewhat more difficult, as we usually do not reach the minimum size.

On August 30, 2024, we reached an important milestone in the integration with the completion of the merger of Credit Suisse Asset Management (Switzerland) Ltd. with UBS Asset Management Switzerland AG. The migration of all portfolios to the UBS platform will take place in stages. The Credit Suisse Money Market fund is still managed on the previous platform according to the process described in the fund prospectus. However, the strategy is defined together with the UBS money market team and the fund can now also benefit from the expertise of UBS Asset Management credit analysts for the internal credit assessment.

The economic recovery in Europe and China, which was still apparent in the first half of the year, has so far failed to materialize. In the 3rd quarter of 2024, economic data disappointed in almost all regions. Concerns about growth came to the fore. With inflation continuing to decline, it is not only the market's hopes of interest rate cuts that have risen significantly, leading to falling bond yields. Almost all major central banks have now cut interest rates. After Donald Trump's victory in the US presidential election, interest rates rose initially in anticipation of a higher fiscal deficit and continued higher inflation. But investors' focus soon turned to the expected interest rate cuts, which caused interest rates to fall again. In view of the progress made in fighting inflation and the slowdown in the labour market, the Fed lowered the target range for the key interest rate by another -25 bps to 4.50%-4.75% in November. At the same time, they held out the prospect of further interest rate cuts. In addition, the Fed will continue to reduce its balance sheet.



Due to the inverted yield curve, we tend to keep duration short and invest primarily in the maturity range of up to 6 months. In terms of investments, we focus on diversification and liquidity. The fund volume declined continuously in the reporting period. Due to the smaller fund size, we are investing mainly in bonds with remaining time to maturity of around one year or below. The liquidity and supply allow for a broad diversification of issuers. Investments in commercial paper have become somewhat more difficult, as we usually do not reach the minimum size.

On August 30, 2024, we reached an important milestone in the integration with the completion of the merger of Credit Suisse Asset Management (Switzerland) Ltd. with UBS Asset Management Switzerland AG. The migration of all portfolios to the UBS platform will take place in stages. In the 3rd quarter of 2024, economic data disappointed in almost all regions. Concerns about growth came to the fore. With inflation continuing to decline, it is not only the market's hopes of interest rate cuts that have risen significantly, leading to falling bond yields. Almost all major central banks have now cut interest rates. At the their quarterly assessment on 26 September, the SNB eased its monetary policy again and lowered the key interest rate by a further -25 bps to 1.0%. This third interest rate hike this year was justified by a further decline in inflationary pressure and reflects, among other things, the appreciation of the franc over the last three months. Inflation has been lower than expected since the last assessment of the situation. Lower prices of imported goods contributed mainly to the decline. The SNB also continued to assess the downside risks to inflation to be higher than the upside risks. Contrary to its general practice, it held out the prospect of further interest rate cuts in the coming quarters for the first time. The new conditional inflation forecast is well below the forecast of the previous quarter. The stronger Swiss franc, the lower oil price and the electricity price reductions announced for next January 2025 are contributing to the downward revision. Second-round effects are likely to be smaller.

Due to the inverted yield curve, we shortened duration somewhat in the first half of the reporting period. Towards the end of the reporting period, however, we increasingly invested in slightly longer maturities again, as we expect further interest rate cuts. In terms of investments, we focus on diversification and liquidity. The fund volume has decreased continuously in the beginning of the reporting period but has risen sharply again since the end of October. The supply of CHF bonds issued by foreign issuers during the year is low and due to the small fund size, investments in commercial paper have become somewhat more difficult, as we usually do not reach the minimum size. Therefore, we try to coordinate reinvestments with other money market funds within the Group whenever possible.



On August 30, 2024, we reached an important milestone in the integration with the completion of the merger of Credit Suisse Asset Management (Switzerland) Ltd. with UBS Asset Management Switzerland AG. The migration of all portfolios to the UBS platform will take place in stages. The Credit Suisse Money Market fund is still managed on the previous platform according to the process described in the fund prospectus. However, the strategy is defined together with the UBS money market team and the fund can now also benefit from the expertise of UBS Asset Management credit analysts for the internal credit assessment.

The risk profile and the general risks of the sub-funds are defined in the UCITS V prospectus (including the constitutive documents) of Credit Suisse Funds SICAV of December 20, 2022. The range of investment opportunities from which the portfolio manager can choose when making investment decisions depends on the size of the fund assets of the individual sub-funds of the SICAV. If the fund assets decrease due to an increase in redemptions, the investment universe may also change, always in compliance with the investment policy guidelines.
